

## Errata Note: 2020 EAVS Comprehensive Report and Accompanying Dataset

December 18, 2023

The state of Washington requested to make corrections to their data submissions for the 2020 EAVS following the initial publication of the comprehensive report and dataset on August 16, 2021. These corrections are documented below.

### **2020 Election Administration and Voting Survey Dataset**

The corrections listed below are reflected in Version 1.2 of the 2020 EAVS dataset released in December 2023.

- Washington provided updated total number of confirmation notices sent to registered voters (A8a), total confirmation notices received back from voters confirming registration (A8b), total confirmation notices received back confirming registration should be invalidated (A8c), total confirmation notices returned back as undeliverable (A8d), total confirmation notices that were status unknown (neither received confirmation nor returned undeliverable) (A8e). Statewide and nationwide A8a-e totals did change.
- Washington added the following comment in A8\_Comment for all of its jurisdictions: “VR SYSTEM CHANGE IN JUNE 2019. BETWEEN 6/1/2019-10/26/2020 ARE TOTAL NOTICES. BETWEEN 10/29/2018-6/1/2019 ARE TOTALS FROM CONVERTED DATA.”; the comment section was left blank in the last version of the dataset.
